#### **Traditional IRA Minimum Required Distributions**

Like many Americans, you probably set aside some money from your paychecks for your retirement. Maybe you invested in a traditional IRA, a 401K, a 403B, a 457 or some other such plan. If so, that's great. Now it's time to enjoy your savings. If you have been receiving regular distributions from your retirement plan(s) that meet the minimum withdrawal requirements for people over age 70 1/2, this discussion will not apply to you. Also, minimum distributions from Roth-IRAs do not apply to the IRA owner while he/she is still alive. Further, while the minimum distribution rules from 401Ks, 403Bs, etc. are similar, this writing will focus on withdrawals from traditional IRAs.

If, however, you have decided that you want to pass your traditional IRA on to your heirs intact, or you don't want to withdraw any funds until later in life, say 75 or older, you could run afoul of some serious tax laws. Once you reach age 70 1/2, you must begin withdrawing a minimum amount, called the Required Minimum Distribution (RMD), from your IRA each year. The initial withdrawal must not be later than April 1st of year following that in which you turn 70 1/2.

Example. You reach age 70 1/2 on August 20, 2016. For 2016, you must receive the RMD from your IRA by April 1, 2017. You must then receive the RMD for 2017 by December 31, 2017.

If you take out more than the RMD for a given tax year, you cannot apply the excess towards the following year's RMD. All withdrawals from IRAs are reported and taxed in the year they are withdrawn. Further, distributions from a Roth-IRA cannot be used to satisfy the RMD requirements for a traditional IRA.

Failure to withdraw the required minimum amount in any given year may result in your having to pay a 50% excise tax on the amount not withdrawn. See Publ. 509-B, page 27.

This discussion is meant to be a general interpretation of rules pertaining RMDs from traditional IRAs and is no way intended to be construed as tax advice for a particular situation. The reader should contact a qualified tax preparer for specific information concerning his/her taxes.
